Introduction

1. Collection of Personal Information

The following types of personal information may be collected, processed, stored, and used:

Information about your computer, including IP address, geographic location, browser type and version, operating system.

Information about your visit to and use of this site, including the source of the link, the duration of the visit, the pages viewed, and how you navigate the site.

The information you enter when filling out the electronic request for a session : your first and last name, gender, date of birth, telephone number, email address, as well as any other personal information you provide to us when filling out the electronic request for a session.

Information relating to purchases of services you make on our site, including credit card information, bank account details or any other of your payment details, order and purchase history of services and goods, comments, testimonials, product reviews, recommendations.

2. How do we collect personal information?

Your personal information is collected through the “electronic request for a session” form.

2. How do we use your information?

Personal information provided to us through our website will be used for the purposes described in this Policy or on the relevant pages of our website. We may use your personal information to:

To provide you with the services and goods purchased on our website.

Send statements, checks, invoices, confirmations and payment reminders, and collect payments.

Provide assistance and technical support to our Users.

Communicate with our Visitors and Users through general or personalized service-related notifications, marketing and promotional messages.

To improve the administration of our website and the services we provide and customer support.

Deal with inquiries and complaints related to our website or about you.

Provide statistical information about our users to third parties (although third parties cannot identify individual users from this information).

Comply with all applicable laws and regulations.

3. Disclosure of Your Personal Information

Except as otherwise stated in this policy, we do not share your personal information with third parties except as follows:

When required to do so by law.

In connection with any ongoing or future legal proceedings.

To establish, exercise or defend our legal rights (including sharing information with third parties for the purposes of fraud prevention and credit risk reduction).

4. Security of Your Personal Information

We take reasonable technical and organizational precautions to prevent the loss, misuse, or alteration of your personal information. The personal information you provide is stored on secure servers (protected by a password and a firewall) hosted by Infomaniak. However, please remember that, due to its nature, no data transmission over the Internet is completely secure and we cannot guarantee the security of your information.

5. Use of cookies

Cookies provide information about the computer used by the visitor. We may use cookies, as necessary, to collect information about your computer to help us improve our site.

Using cookies, we may collect information about your general internet usage. If used, these cookies are downloaded to your computer and stored on your computer's hard drive. This information does not identify you personally. This is a statistical figure. These statistics do not contain any personal information.

If you wish, you can change the settings on your computer to prevent the use of cookies. This can be easily done by enabling the cookie rejection setting on your computer.
